

## Life Esidimeni Inquest Inquiry starts today – live stream from 10am

After 5 years since the Life Esidimeni tragedy, an Inquest Inquiry will begin today, 20 July 2021, in the Pretoria High Court. The Inquest, which will be lead by Judge Mmonoa Teffo, will determine if anyone can be held criminally liable for the tragedy in which at least 144 mentally ill patients died.

Section 27 will be representing 44 families that were directly affected by the tragedy and will be giving testimony and evidence. Umunyana Rugege, Section27 Executive Director, said, "This is a fact-finding mission. It is an important and serious process, and we have faith in it to get to the bottom of the cause of the deaths. Causation is a difficult issue in law. Part of seeking justice is about seeing real accountability."

Life Esidimeni Family Committee representative Christine Nxumalo said: "It is all part of closure. What the families want is to hold those responsible accountable, and this is also part of that."

The Inquest Inquiry is an important step to advocate for justice, accountability and better treatment for mental health. We can #NeverForget what happened to the most vulnerable population and ensure it never happens again.


